- 3.4. be a natural person and not a juristic entity, which juristic entity includes but is not limited to a Business to Business [B2B] partner of the Organiser, cross border partner or retail partner of the Organiser. The product must be purchased in the participant's name; and
- 3.5. purchase any of the qualifying models from a participating store while stocks last, on or before 2 April 2017.
4. Offer:
 - 4.1.
